The Articles of Organization for Sibades, LLC were filed on January 28, 2015 and assigned Florida Document Number L15000016620.


1. Article III of the Articles of Organization of Sibades, LLC is amended to read as follows:

**ARTICLE III

MANAGEMENT**


The Company shall be managed by a Manager (the "Manager") as further provided in the Operating Agreement. The names and addresses of managing member/members are:
